Old Business

- Q12 Congregation Survey & Discussion of wording questions
 - Dave gave everyone handouts of Gallup Poll questions and also sample questions from the Vanco Faith Website.
 - Dave asked the group to read through the questions and come to the next meeting prepared to discuss.
 - Chris suggested also asking questions about how people feel they are engaged with the church.
 - Chris would like to work with Ryan to see if there are other faith communities in the area that have used a O-12 type survey to see if there is any information we could use.
 - We need to persuade the congregation that their input matters.
 - Pastor Jamie said we can do a larger survey, but to keep in mind that we can also do smaller, more focused, surveys along the way.
 - O Jan suggested that we use the survey as a way to connect with those who are unable to attend.
- Dee Schlieve as Communications Admin
 - Sue motioned to accept Dee for the position of Communications Admin, Jan seconded the motion. The motion was unanimously approved by the group.
- Committee Sign-ups, Staff Connections (Need council reps on: Trust Fund, Property, & Preschool)
 - The list was updated to include connections with new council members.
